THE NEW YORK STATE PUBLIC SERVICE COMMISSION CREATED THE ENVIRONMENTAL DISCLOSURE LABEL PROGRAM TO TRACK AND PUBLISH THE SOURCE OF ENERGY FOR EACH ENERGY SERVING ENTITY IN NEW YORK STATE.

IDEALLY, AN ENVIRONMENTAL DISCLOSURE LABEL WILL GIVE CUSTOMERS THE INFORMATION NECESSARY TO EVALUATE THE BUYING HABITS OF EACH ENERGY COMPANY COMPETING FOR THEIR BUSINESS, HELPING A CUSTOMER SHAPE THEIR DECISION BASED ON THE VALUES THEY HOLD DEAR AND HOW THEY MATCH THOSE OF THE ENERGY SUPPLY COMPANY THEY ARE EVALUATING. MOST UTILITIES BUY ENERGY FROM THE NEW YORK SPOT MARKET. WE ALSO BUY THE RIGHTS TO THE POWER GENERATED BY ZERO EMISSION WIND AND CERTIFIED LOW IMPACT HYDRO RESOURCES THAT ARE DELIVERED TO THE NEW YORK STATE POWER GRID.
